## TRUST DEED

This Deed of Trust made this the 30th day of May 2003 at Kathua between Sh. Pankaj Kumar Dogra son of Sh. Joginder Nath R/o Ward No 2 Kathua. hereinafter called the "SETTLOR" ( which expression shall unless exclude by or repugnant to context be deemed to include his executors, administrators and representators) of the ONE PART and (1) Smt. 
